**Organized Group/Day Care/Day Camp Program Policies and Procedures**

On Behalf of the City of Independence, welcome to Adventure Oasis Water Park. We are pleased that you are planning to visit our facility and hope you have a pleasant and enjoyable experience.

These policies and procedures are outlined specifically for all organized groups and day care/day camp programs intending to visit our water park. We ask you to read this information in its entirety. This Group Reservation Form and the General Rules and Regulations Sheet must be signed. When the completed agreement and payment are received, your group will then be issued wristbands required for admission to the facility. Wrist bands may only be used for this 2023 Summer Season. Be sure to pick them up at the Roger T. Sermon Community Center front desk any day prior to your rental during operational hours. Lost wristbands will not be replaced.

Group reservations made by registered day cares and schools districts will be available for businesses that are located within and outside the Independence City Limits. They will be held to all rules and regulations set forth in the rental agreement for number of participants ratio to monitors and time allowed in the facility. Non-resident adults included in the group's reservations must be employees of the day care or school district.

These policies are intended to protect your group as well as all the visitors of Adventure Oasis Water Park. If you have any questions, feel free to contact us at (816) 325-7370.

**GROUP RENTAL POLICY:**

- Limited to 3 groups per day Monday through Friday only
- No weekend group rentals
- Ratios - All groups must abide by the established adult to child ratios. Two swimming adults (16 and older) for every 5 youth ages 2 to 4. One swimming adult (16 and older) for every 8 youth ages 5 to 12 years.
- Fees are based on the address of the organized group/day care.
  - **Organized Group Rate:**
    - \$150 for 20 - 40 persons
    - Each Additional Participant: \$4 resident/\$6 non-resident
    - Max: 60 persons
  - **Licensed Day Care/Day Camp Rate:**
    - Minimum participants: 20
    - Resident Rate - \$4 each
    - Non-Resident Rate - \$6 each
    - Max: 60 persons

**GROUP REFUND POLICY:**

- Refunds in full can be requested up to 14 days prior to reservation date.
- Refunds requested less than 14 days prior to reservation date up to reservation date will receive a 50% refund.
- Refunds requested after reservation date are not guaranteed, will be considered on a case by case basis and will be limited to a 15% refund.

**For Protection Against Recreational Water Illnesses (RWIs):**

- **PLEASE** do not swim when you have diarrhea. This is especially important for children in diapers.
- **PLEASE** do not swallow the pool water.
- **PLEASE** practice good hygiene. Take shower before swimming and wash your hands after use of toilet.
- **PLEASE** take your kids on bathroom breaks and check diapers often.
- **PLEASE** change diapers in a bathroom and not at poolside.
- **PLEASE** wash your child with soap and water before swimming.

## Adventure Oasis Water Park 2023 General Rules and Regulations

These rules and regulations are intended for the safety of all guests. The patron is responsible for reading and obeying the rules. A patron who violates these rules may be asked to leave the facility. Staff has the discretion to create and enforce additional rules as necessary.

### Water Park Rules:

1. Swimsuits - **Swim attire appropriate for a family water park** must be worn (no cut-offs, shorts, leotards, etc.). Appropriate body coverage must be maintained at all times (no thong suits, etc.).
2. Tobacco - No tobacco products, (smoking, vaping or chewing) will be allowed inside the pool enclosure. Those wishing to use tobacco products may have their hands stamped and can then pass outside the facility. There is no smoking allowed within 15 feet of entrance.
3. Alcoholic Beverages - The possession or consumption of alcoholic beverages is not permitted inside the facility during normal business operations.
4. Under the Influence - Any person suspected of being under the influence of a controlled substance will not be allowed entry to the facility; or, if inside the facility, will be asked to leave.
5. Food and Drink - No food or beverages (with the exception of sealed water bottles) of any type may be brought into the facility.
6. Improper Behavior - Running, rough play, roughhousing, and obscene gestures or language are not allowed. Determination that these acts are occurring is left solely to the discretion of the pool staff.
7. Blood Borne Pathogens - Swimmers with open wounds will not be allowed admission.
8. Lost Items - The City of Independence is not responsible for lost or stolen articles. Lost and Found will be cleaned out each Wednesday.
9. Deck Furniture - Deck furniture may not be placed in any pool or beach entry, and must remain in a position so as to allow free access to pools at all times. Deck furniture may not be moved from designated pods/areas.
10. Young Children - Children under the age of 13 must be accompanied at all times by a responsible person age 16 or older. All parents or guardians must be within arms reach of non-swimmers.
11. Adult Supervision - A ratio of 2 swimming adults to every 5 children must be met for all groups with children ages 2 - 4. For groups with children ages 5 - 12 the ratio must be one swimming adult for every 8 children.
12. Chewing Gum - Chewing gum will not be allowed inside the facility at any time.
13. Swimming Skills - Appropriate swimming skills may need to be demonstrated through water testing before using the diving boards or entering deep-water areas. Water testing will consist of swimming across one width of lap pool without stopping and treading water 30 seconds.
14. Lane Ropes - Hanging on lane ropes will not be permitted.
15. Music Devices - Headphones/ear buds must be used when listening to music.
16. Pool Toys - Inflatable rafts and noodles will not be allowed at any time. No Nerf® or other absorbent balls will be allowed at any time. Flotation devices must be U.S. Coast Guard approved and labeled as such. All other water toys and inflatables are subject to approval by the pool manager.
17. Diapers - Swim diapers will be required of all infants and toddlers swimming in the facility. They are available for purchase at the front desk.
18. Other Conditions - Pool management reserves the right to modify these rules as situations dictate. Failure to follow directions from Adventure Oasis Water Park staff will result in the removal from the facility.
19. Wrist bands will not be replaced if lost or forgotten. It's the party's (group's) responsibility to keep track of their wristbands.
